CIRCULAR NO. 41 N/2024: A CIRCULAR TO FOREIGN REINSURANCE COMPANY

APPLICATION FOR ACCREDITATION OF REINSURANCE COMPANY FOR THE YEAR 2025

The application for accreditation for the year 2025 is to be made through TIRA Online Registration System (ORS) that is accessible through https://ors.tira.go.tz/#/. (Guideline on submission of documents is hereby attached).

All foreign reinsurers seeking to transact insurance business with Tanzanian registered insurers must earn an Accreditation Clearance Letter from TIRA which will be issued to successful applicants upon:

The following information (alterations/additions) shall be filed in the TIRA ORS;

- 1. Payment of fees:
 - i. Non-refundable application fee of USD 1,000; and
 - ii. Accreditation fee USD 9,000.
- 2. Copies of Certificate of Incorporation from Home jurisdiction.
- 3. Copy of active license issued by regulator In home jurisdiction.
- 4. Status of regulation by regulatory Agency in home jurisdiction.
- 5. Credit rating by a reputable rating agency.



 - i. Beneficiary name;
 - ii. Beneficiary account number;
 - iii. Beneficiary bank address; and
 - iv. Beneficiary swift code
- 10. Details of the board member.
 - i. Name of each board member
 - ii. Date of appointment
- 11. Details of the senior management.
 - i. Name of each senior management
 - ii. Passport of each senior management
- 12. Any other relevant information.
