“CIRCULAR LETTER NO. 81/2019 (COMPLIANCE WITH BANCASSURANCE REGULATIONS)

TO: ALL BANKS AND FINANCIAL INSTITUTIONS OPERATING AS INSURANCE BROKERS

SUBJECT: COMPLIANCE WITH BANCASSURANCE REGULATION 28(2).

Regulation 28(1) of The Insurance (Bancassurance) Regulations, 2019 states that “Notwithstanding the provision of Regulation 27(2) of these Regulations, a bank or financial institution carrying on insurance broking on commencement of these Regulations may continue to carry on insurance broking business for a period of not more than two years, unless, on application, an extension is granted by the Commissioner which shall not exceed one year”.

The said Regulation came in force on 15th March 2019; you are hereby issued with an extension of up to 15th March, 2021. Therefore your insurance brokers’ license will cease at that date.

By this letter, you are encouraged to comply with the aforesaid regulation before the indicated deadline.

Relevant registration documents should be submitted physically at TIRA’s Head Office, Dar es Salaam Office, Zanzibar Office and Zonal Offices.

It is suggested that the application be sent by a registered mail or personally delivered to the following person(s) in any of our offices.


